

Drinking Water Pre-treatment Optimization Course

COURSE DESCRIPTION:

This course expands on the principals of chemical coagulation, flocculation and filtration touched upon in the Water Treatment Core course. It will provide the participants with a working understanding of the key objectives of chemically assisted filtration to improve process control and improve finished water quality. The course will utilize the optimization of a Conventional Nova Scotia Water Treatment Plant as a case study to provide an example of how fundamental principals of coagulation, coagulants, pH, alkalinity and polymers were used to evaluate and optimize the pretreatment process to achieve treatment objectives.
